Item 6. Other academic activities in the Department.

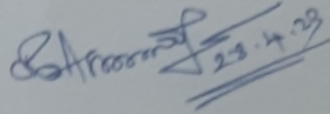
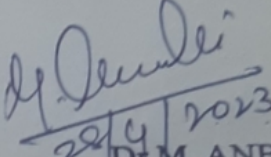
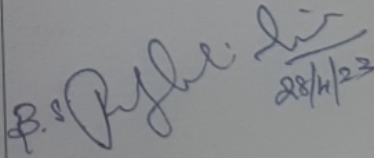
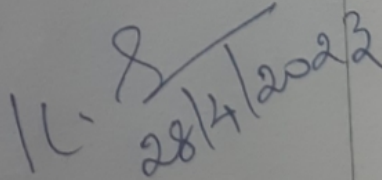
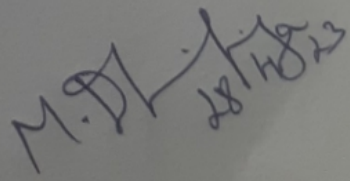

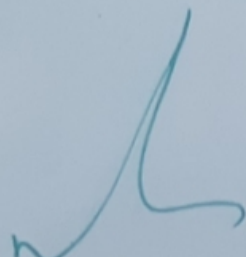
Other Academic Activities:

- Feedback has been collected from all the stakeholders and it has been analysed.

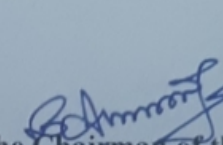
