Item: 1

The members of the board unanimously agreed to confirm the minutes of second meeting of Bos for the academic year 2017-18.

Item: 2

The members of the board suggested to add the topic 'Non-Trading concern' in Unit I of Semester I subject 'Principles of Accountancy'. The topic 'Bank

Reconciliation Statement' was shifted from Unit I to Unit III in the same subject.

Item : 3

The members of the Board approved to interchange the third semester subject 'Business Economics' with the first semester subject 'Introduction to Information Technology'.

Item : 4

The members of the Board agreed to shift all the topics of III unit of II semester subject 'Mercantile Law' to Unit II. Unit III was included with the topics 'Contract of Indemnity and Guarantee, Contract of Bailment and Pledge - Contract of Agency'.

Item : 5

The members of Board consented to eliminate IV Semester subject 'Business Environment'. Instead, new paper 'Accounting' III Semester Subject 'Industrial Law' has been shifted to IV Semester to fill this gap. In II Semester, new paper 'Accounting Standards' was introduced. In the 'Industrial Law' subject, Unit I is updated with the topic 'Employees' State Insurance Act (ESI)'.

Item : 6

The members of Board advised to include 'Preparation of P&L A/c' in Unit I of IV Semester Subject 'Partnership Accounting'. From Unit I, the following topics have been moved to Unit III:

Calculation of new ratio - Sacrificing ratio - Evaluation of assets and liabilities.

In Unit III of the same subject, the topic 'Gaining ratio' was added. Then, Unit IV and Unit V are interchanged with their respective contents as such.

Item : 7 :

The members of the board agreed to add the topic 'Pro-Rata allotment' in Unit I and 'Revised Schedule 3' in Unit II of the subject 'Corporate Accounting' during the fifth semester.

Item : 8 :

The members of the board resolved that in Semester V, 'Financial Management Subject', Unit I is updated with the topic 'Computation of dividend under Walter and Gordon's Model.'

Item : 9 :

The members of the board advised to ~~eliminate~~^{modify} the 'Direct tax' subject. in VI

Item : 10 .

The members of the board resolved that in Unit II of VI Semester subject 'Management Accounting', the topic 'determinants working capital requirements' is to be added.

Item : 11 .


The members of the Board agreed to update Unit I of VI Semester subject 'Principles of Auditing' with the topic 'Introduction to standard audit framework'.
