

Item 5	To award assignment marks (5) based on the presentation skill in each subject.	It is resolved to introduce a new system of awarding marks for Assignment especially for <u>III</u> BA literature students. Instead of written assignment the students may give the presentation based on the topic given to them. To have effective presentation the department can be equipped with LCD Projector or OHP.
