Wise). Hence, you are directed to ensure the OMR Answer Sheets supplied, pertain to your hall at the time of verifying adequacy of examination materials. You are also being directed to take utmost care and instruct the Invigilators to ensure that the OMR Answer Sheet issued to the candidate belongs to the particular candidate.

In any extraordinary circumstances, if the need of replacing the preprinted OMR arises to any candidate, spare OMR (Blank) supplied to each venue (20 Nos) may be utilized and specific report has to be submitted to the Controller of the Examination along with the cancelled OMR answer sheet, mentioning the reason, as to why the spare OMR Answer Sheet was supplied.
