The chairman briefed the activities to be taken up by the Bos through discussion and approval with regard to the updation of syllabi for the academic year 2017-18. The chairman, after then requested the members to take up the agenda for the discussion and approval. The chairman of Commerce (PG) moved the agenda. Feedback of stakeholders have been collected and analysed.

Item : 1

The members of the Board unanimously agreed to confirm the minutes of eleventh meeting of Bos for the academic year 2017-18.

Item 2:

The members of the Board approved to include the topic 'Practical approaches in PLC of select product' in Unit III of Semester I subject 'Marketing Research'. The included topic is suggested to consider as a self study portion.

Item 3:

The members of the Board advised to add the topic 'Digital Economy - Cashless economy - Cause and effects' in Unit III of Semester I subject 'Global Business Environment'.

Item 4:

The members of the Board resolved that the topic 'Preparation of B/sheet as per Schedule 6' in Unit I of Semester II subject 'Advanced Accountancy' is ~~now~~ replaced with 'as per Schedule 3'. The title of the subject is rephrased as 'Advanced Corporate Accountancy' because of the weightage of the contents.

Item 5:

The members of the Board advised to add the topic 'Gold and Real Estates' as investment alternatives in Unit IV of Semester II subject 'Security Analysis and Portfolio Management'.

Item 6:

The members of the Board approved to update Unit I of Semester II subject 'Management of Small Enterprises' with the topic 'MSME Act 2006 - Salient features' and 'Government support to women'. In the same subject, Unit III is updated with the topic 'Role of Commercial Banks and SIDBI'.

Item 7:

The members of the Board asked to shift the topic 'tax avoidance and tax evasion' from Unit I of III Semester subject 'Applied Taxation I' to Unit I of IV semester subject 'Indirect taxation'. The IV semester subject 'Indirect taxation' is the newly introduced subject after the elimination of 'Applied Taxation II'.

Item 8:

The members of the Board approved to remove the topic 'Spouse and minor child' in Unit IV of III Semester subject 'Applied taxation I' and the topics 'provisions relating to set off and carry forward of losses (problems), clubbing of incomes v/s 64 have been moved to Unit IV of the same subject in order to equalise the contents of the units. The topic of 'Applied Taxation I' is changed as 'Income Tax Law & Practice' in Semester III.

Item 9:

The subject Applied Taxation II is fully revamped and in the newly introduced subject 'Indirect taxation' in Semester IV, 'Indirect taxation features, customs duty and GST collection & levy' topics have been properly included as per the advice and consultation of the BAS members.
