The Chairman welcomed the members of the Board of Studies in Commerce (CA). The members introduced themselves.

The chairman briefed the activities to be taken up by the Board for implementation during the current academic year. The chairman then requested the members to take up the Agenda for discussion and approval.

Then he explained the objectives and the various components of Choice Based Credit System (CBCS). CBCS consists of three Parts

Part I and Part II deals with languages. Part III (A) comprises of Core Papers and Part III (B) set aside for elective Papers, skill based subject, Non-major Elective Paper (NME), Job oriented Courses (JOC), Value Based Courses (VBC) and Co-Curricular activities. Further, the Chairman explained the meaning of Credit and how it is assigned to each and every course how the grade points would be assigned based on the marks secured by the students in each course and how Grade Points Average (GPA) and Overall Grade Points Average (OGPA) would be calculated. Then, he moved to Agenda.

Item : 1

TO introduce a new Concept in Tally Practical syllabi namely Tax rate, interest rate calculations, VAT.

Item : 2

TO revamp the Indian Banking syllabi with a new concept in Unit V with NEFT, RTGS and Core banking.

Item : 3

TO replace a topic "Standard Costing" in Cost Accounting syllabi in Unit V only with simple problems instead of Costing of Joint product and By Product.

Item : 4

To replace the subject of "Principles of Insurance law" with Research methodology

Item : 5

Instead of the topic "Scope of Income, charge of Tax" in Applied Taxation I syllabi, replaced as "Incidence of Tax" in unit I.

To include a topic "clubbing of Income" after the topic "Set off and carry forward and set off of losses in unit V.

Item : 6

To specify the methods for Depreciation for unit I in financial Accounting syllabi such as Straight line method, Written Down Value method, Annuity method and Insurance Policy method.

Stock and Debtors method with simple problems is to be specified for unit II in Hire Purchase and Installment

Debtors system and Stock and Debtors system methods are to be specified in unit III for Branch Accounts. Feedback have been collected from all the stakeholders and analysed.
