**MINUTES OF THE STUDENTS WELFARE AND GRIEVANCES REDRESSAL
COMMITTEE MEETING**

The meeting of the Students Welfare and Grievances Redressal Committee was held on 06.03.2014 by 12.00 noon in the Conference Hall. The Secretary chaired the meeting and the Principal coordinated the proceedings.

The Meeting commenced with a formal prayer song by the students. The Secretary presented an overview history of the institution and its uniqueness in various aspects. He also asserted that the Management, members of staff and students belong to one family and exhorted to focus on students-centric issues.

1. Mr. Santhosh of II BCom complained against the poor maintenance of the Basket Ball court.
The Joint Secretary assured to take necessary steps to maintain the Basket Ball court from next month onwards.
2. Ms. Haripriya of II BCom CA expressed her dissatisfaction about the working condition of water purifier and added that the announcements made through the speaker are not audible.
The Joint Secretary promised to take appropriate steps by referring to the maintenance department.
3. Ms. Pradeepa of II MA complained that reference books should be issued for circulation in the library.
The Principal answered that normally the reference books in any library will not be lent. But taking photocopies can be permitted. The Principal recommended the library hour for PG Programmes could be included in their regular time table.
4. Ms. Pradeepa of II MA suggested to purchase more books on American Criticism.
The Joint Secretary replied positively to purchase the books.
5. Ms. Saranya of III Maths complained that the size of the black board in their class room (B 26) is small and the writings are invisible.
The Joint Secretary referred to the maintenance department.
6. Ms. Sumithra of IBC expressed her wish to have Talent Day celebration.
The Principal informed that from the next academic year onwards, an Inter-departmental competitions will be conducted.
7. Ms. Gayathri of II Biotech expressed her genuine concern that the wash basins are blocked by the waste materials.
The Joint Secretary appreciated her for her responsibility and civic sense. She assured to instruct the housekeeping take extra care.

8. Ms. Madhumitha of II MSc Physics complained about the increasing number of cats in the hostel.
The Joint Secretary informed that necessary actions will be taken for the above said complaints.
9. The college President Prabhakar suggested to improve the quality of the ID card and to increase the length of the lanyard.
The Joint Secretary approved it.
10. Ms. Geetha of II BSc IT suggested to change the colour of the uniform saree and reported to improve the quality of the saree.
The Joint Secretary opined that the colour of the saree cannot be changed as it is followed traditionally. But the material of the saree will be replaced with a better one.
11. Mr. Saravanan of III BA English proposed that the attendance and results can be forwarded through SMS for the convenience of the individuals.
The Controller of Examinations assured it in the near future.
12. Mr. Subramanian of III CT requested to have a tiled pathway from the main entrance of our college which will be convenient especially during the rainy season.
The Joint Secretary considered this and referred to the maintenance department.
13. Mr. Ramesh of III BSc BT emphasized the use of helmets by the students.
The Joint Secretary appreciated and asked the student volunteers to take care of ; The students should wear the helmets and they are responsible for keeping the helmet safe.
14. Mr. Santhosh Kumar of II BCom requested to have a separate Foot ball ground.
The Physical Director informed that due to lack of space place constraints it is impossible to have a separate foot ball ground.
The Joint Secretary suggested that the college foot ball team could be tied with private clubs for the betterment of the players and games.
15. Mr. Suresh of I BSc Chemistry suggested that the sewage water from chemistry department leaks through the playground which affects NCC cadets during their parade.
The Joint Secretary assured to take steps to rectify this by June.
16. Ms. Ashwini of I BSc Botony requested that Microscopes in the Botany Lab are not up to the point of utility and also wished to have smart classrooms.
The Principal promised to refer to the head of the department concerned. There are two smart class rooms and the students can make use of them effectively. The Joint Secretary referred to maintenance department.
17. Mr. Saravanan of I BCom requested to mend the restroom locks. She also added that circulars from Tamil department are not regular.
The Principal assured that she will look into the matter.

18. Ms. Divya of III BA requested to change the Black board before the conference hall.
The Joint Secretary informed that the order has been placed already.
19. Mr. Aakash of II MA English represented to replace the fans which are not functioning properly.
The Joint Secretary assured to rectify the above said issue.
- ✓ 20. Ms. Nivetha of II BSc CS suggested to have Hostel Day celebration.
The Joint Secretary agreed and assured that it will be implemented from the next year.
21. Many students complained regarding sports and the individual events of the students like Athletics were not conducted properly. Therefore there was a lot of confusion in the group events. Moreover the student referees caused a lot of problems in the absence of the Physical Director. The students suggested that the events can be organised from the month of January in order to avoid partiality and haphazard conduct of the events.
The Physical Director replied that she was the only Sports Director available on the campus to look after all the games and sports effectively. The Principal promised to take necessary steps with the consultation of the athletes. The sports events could be conducted in an organised way from the next academic year.
22. II Year CDF students reported that the Gents' rest room is situated near their classroom which makes the students feel inconvenient.
The Principal promised to consider, and take necessary action to prevent the inconvenience due to foul smell.
23. An NSS volunteer informed that recycling of water bottles is undertaken in a nearby factory. He also suggested that the NSS volunteers of KASC can undertake the above said work in the campus.
The Joint Secretary appreciated and promised to enter an MOU with the factory in near future.

STUDENTS' GRIEVANCE REDRESSAL COMMITTEE MEETING ON 24.01.2018

MINUTES OF THE MEETING

The students' Grievance Redressal Committee meeting was convened on 24.01.2018 at 11.30 a.m. in the Seminar hall of the college. All the class representatives and council members attended the meeting. Dr. C.A. Vasuki, Secretary & Director asked the students to express their grievances. Dr. V. Balasubramaniam, Principal and Dr. M. Revathi Bala CEO i/c were present. The minutes of the meeting were as follows:

- i. Students requested to nominate a cultural head from staff side for rectifying the problem of one department representation in the inter-collegiate meet / competitions.
 - Request of students has been taken into consideration.
- ii. PG students expected the Net coaching class inside the campus.
 - The management has consented to fulfill the requirement of the students.
 - The students were advised to compare the NET – UGC syllabus with the college syllabus in order to enrich the quality of the syllabus.
- iii. PG students requested for the increase in Library cards.
 - Librarian consented to issue the cards on or before February 2018.
- iv. Students of CMA / CPT requested for class room arrangements which will enable them to prepare neatly and avoid sitting at the back side of canteen.
 - The authorities agreed to make bench arrangements nearby generator room.
- v. Students demanded for smart class training in order to handle the equipments efficiently.
 - Librarian consented for the training arrangement on the next day itself in C – 49.
- vi. PG students of Science departments demanded the change in timing of classes between 8 am and 1 pm in order to save the time in the afternoon and go for self study.
 - The authorities expressed the time being inconveniences in the scheduled work load of staff members handling both UG and PG classes.
- vii. Students pointed out their problems while attending the interviews. They demanded special initiatives to improve their communicative skills.
 - Students are asked to make use of language lab and the special arrangements of English professors and students to conduct spoken classes.

- Placement officer consented to arrange special classes for 'Communicative skills' after the completion of I CIA examinations.
- viii. Students wanted for releasing 'Students monthly newsletter'.
- The students were asked to approach the professors of Department of English and release the newsletter.
- ix. Students expressed their issues to remit the college fees at the last date by standing in big queues.
- They were advised to use Online Payment Facility to avoid last minute rush.
 - They were informed about the 'Pay option in the web site' from the next year onwards.
- x. Students expressed their grievances regarding mobile phone thefts.
- They were advised not to bring mobile phones and valuables to the college as notified in the calendar of the college.
- xi. Students have brought to the notice of the authorities about the improper functioning of Public Announcement System in 'C', 'E' and 'F' blocks.
- The management came forward to fit extra amplifier.
- xii. Students complained about the sweeping arrangements at 4 p.m. itself. They requested to do the arrangements at 4.15 p.m. in 'C' block.
- Their requests were considered by the authorities.
- xiii. Students expressed their difficulties regarding the lock and key system at the time of department functions.
- As the system is efficient and right for preventing the thefts, the students are advised to approach the in-charge of the lock and key at the college gate.
- xiv. Students those who suffer from serious illness are requested for special consideration in 'attendance'.
- The authorities agreed to consider the special cases with proof.
- xv. Football players requested for ground facility.
- Physical directress explained the arrangements available such as connectivity with clubs and special coach.
- xvi. Students expressed the need for transport arrangements at the time of participating competitions and seminars in other colleges.

- Office Superintendent consented to give connectivity with the transport agencies.
- xvii. English Department students asked for the acceptance of stitching orders given by them to CDF Department.
- CDF Department girls came forward to accept the orders. They insisted that the last minute orders could not be entertained.
- xviii. PG Biochemistry students requested for the inputs of various teaching faculty. They also expressed about the shortage of chemicals.
- The management came forward to consider the requests from the students to equip the Biotechnology Department with additional chemical requirements.
- xix. Students have asked to announce the prize winners of various competitions by using Public Announcement system.
- The students were directed to contact the Cultural Club and Principal for deciding about the announcements.
- xx. Students put forward for entertaining the participation of all NSS volunteers in various camps.
- NSS officers and coordinators consented to give opportunities for all in future according to the financial viability.
- xxi. 'Special Apps' for the college and 'cold and hot' water supply were demanded by the students.
- The management agreed to make necessary arrangements. The students were insisted by the Secretary for using the 'Suggestion box'.

 - They were advised not to bring mobile phone and valuables things to the college during the examination time.





The students were asked to fill the Ragging Affidavits Online and submit the same to their concerned departments.



