MINUTES OF THE MEETING OF THE RESULT PASSING BOARD END-OF-SEMESTER EXAMINATIONS, APRIL 2017

The Result Passing Board meeting was held on 09.05.2017 at 10.30 a.m. in the Seminar Hall. Dr.T.Muraleeswari, Principal and the Chairman of the Board presided over the meeting and the members of the Result Passing Board were present. Dr.B.Vanitha, Registrar i/c, Professor & Head i/c, Department of Econometrics, Bharathiar University Nominee and few members were absent.

A brief account on Examinations of April 2017:

End-of-Semester Practical/Project Examinations were conducted from 05-04-2017 to 15-04-2017. On-line End-of-Semester Examination for the subject Competitive Science II was conducted on 17-04-2017. The Theory Examinations were conducted between 19-04-2017 and 02-05-2017. A total of 3854 candidates had registered, out of which 3848 appeared for the Examinations. The Central Valuation was held on 22-04-2017, 24-04-2017, 28-04-2017, 29-04-2017, 02-05-2017, 03-05-2017 and 04-05-2017.

Agenda for discussion:

Item 1. To consider the award of moderation marks:

From the scrutiny of results of the Examinations of April 2017, it was found that for want of one, two or three marks, there were 187 failures in 126 papers in various UG courses and 28 failures in 37 papers in various PG courses. According to the Autonomous Examination norms, a moderation of 3 marks could be awarded to a paper for a pass, subject to a total of 8 marks, for a maximum of 3 papers per candidate.

Further, 1 student, who failed in 1 paper by one mark in total, may be awarded one mark to pass a paper as per Autonomous examination norms.

I, Dr.S.Logaswamy, COE move that award of moderation of 3 marks to a paper for a pass, subject to a total of 8 marks for a maximum of 3 papers per candidate, to 187 candidates in 126 papers in various UG courses, 28 candidates in 37 papers in various PG courses and one mark to 1 candidate in 1 paper be approved.

Result Passing Board resolve that the above move regarding the award of moderation marks is approved.
