

MINUTES OF THE MEETING OF THE RESULT PASSING BOARD, JUNE 2015

The Result Passing Board meeting was held on 18.06.2015 at 10.05 a.m. in the Principal's Chamber. Dr.T.Muraleeswari, Principal and the Chairman of the Board presided over the meeting. Dr.T.Devi, Professor & Head, Department of Computer Applications, Bharathiar University Nominee and the other members of the Result Passing Board were present.

A brief account of Revaluation and Special Supplementary Examinations:

The revaluation for the final year candidates who applied for revaluation was held on 11.06.2015. A total of 39 candidates, 7 candidates (10 papers) belonging to PG and 32 candidates (67 papers) of UG applied for revaluation.

The Special Supplementary End-of-Semester Examinations for UG, PG & PG Diploma candidates having arrears in final Semester papers were conducted on 15-06-2015 and 16-06-2015. A total of 26 candidates had registered, out of which 22 appeared for the Examinations. The results are placed before the Result Passing Board.

Agenda for discussion:

Item 1. To consider the award of moderation marks:

From the scrutiny of results of the Examinations of June, 2015, it was found that for want of two marks, there were 2 failures in 2 papers in UG courses. According to the Autonomous Examination Rules, a moderation of 3 marks could be awarded to a paper for a pass, subject to a total of 8 marks, for a maximum of 3 papers per candidate.

I, Dr.S.Logaswamy, COE move that award of moderation of 2 marks to a paper for a pass, subject to a total of 8 marks for a maximum of 3 papers per candidate, to 2 candidates in 2 papers in UG courses be approved.

Result Passing Board resolve that the above move regarding the award of moderation marks is approved.

Item 2. To consider and pass the results of Autonomous Special Supplementary End-of-Semester Examinations held in June 2015:



Item 3. Out of 39 students (77 papers) applied for revaluation, 15 papers got change of marks and 62 papers got no change of marks in revaluation. Among 22 candidates appeared in the Special Supplementary Examinations, 18 candidates passed in the final semester arrear papers and qualified for the award of Post Graduate and Under Graduate Degrees in June 2015.
