## **RBI's inflation expectation survey**

- Report -

The RBI Chennai selected Kongunadu Arts and Science College, Coimbatore to conduct the inflation expectation survey in Coimbatore region. The students of the college conducted the survey from 22/06/2017 to 26/06/2017 and completed it successfully. Mr. S. M. Balaji, Assistant Manager and Mr. R. Vijay Lakshman, Assistant from the Department of Statistics and Information Management (DSIM), RBI Chennai visited the college on 21/06/2017 and gave orientation to the students and staff coordinators for conducting the survey in Coimbatore city. Dr. M. Revathi Bala and Dr. S. Uma, Associate Professors of Commerce coordinated the conduct of survey. Dr. M. Venkatachalam and Mr. M. Vivek Prabhu, Assistant Professors of Mathematics acted as the co-coordinators of the survey.

### **Field level Experiences**

Most of the literate respondents could understand the need of the survey and provided the details with due respect whereas people who have low or moderate educational background were reluctant to provide adequate details. The fear of being mislead of their personal and income details bewildered the people and prevented them from providing accurate income and assets details. In the survey, certain questions were probed regarding the approach with money lenders. But the people hesitated to reveal the fact that they borrow money from money lenders, due to their self esteem. The fact that they have borrowed from the money lenders could be identified in a critical way by counter checking some other details on their income and expenditure pattern. Though it was possible for most of the educated people to know the trend and the effects of inflation, they were not able to point out the exact percentage of inflation rate. The uneducated and less qualified respondents were unaware about the trend and effects of inflation.

At the time of field survey, it was observed that there was no change in utilizing the banking services by most of the respondents during the prior and post demonetization periods. They were either not interested or having fear of protection and privacy. The respondents with low level education expressed that they did not have comprehensive guidelines to use the various banking services. It was understood that friends and relatives were the predominant sources of borrowing for the respondents to fulfill their urgent needs and to meet out household expenditures. In the opinion of majority of the respondents, prices of the products and services are increasing in the present year compared to the previous years.

# **Benefits of the survey**

The survey helped to establish proper societal linkages. The opportunity given by the RBI facilitated to realize the role of academic institutions to extend their knowledge and services to the society. The survey covered multiple variables to measure the attitude and the changes in the socio-economic profile of the respondents, especially before and after the period of demonetization. Majority of the respondents (above 90%) welcomed the efforts of the RBI to conduct the survey and know the field level reality with the help of academic linkages. The students allotted to the respective area were able to contact and know the real status of the various strata of the society. This survey would be beneficial to the RBI to frame effective policies for controlling the rate of inflation.

Delivered keynote address. He spoke that Goods and Services Tax (GST) is an indirect tax reform which aimed to remove tax barriers between states and create a single market. Although, it took 17 years to implement, there will be

teething issues, and the real impact of the government's big-bang reform can be assessed only after a full year of its implementation, he added.



Technical Session II was handled by CA.K.S.Shanmugam, Treasurer, Coimbatore branch of SIRC. He spoke that when the clock stroked at midnight on June 30, the GST regime was started to give impact on consumers, traders, businesses as well as the revenue collection machines of the states and the centre. Consumers have no idea about the extent of taxes they pay on goods. So, the consumers would get more benefits due to the introduction of GST, he

added.

Technical Session II was handled by CA.K.Ravi Shankar, Board of Director, Sri Ram Chits (All over India).

The government has notified the rules related to Registration and Composition Scheme of Goods and Services Tax Identification Number (GSTIN) that came into effect from June 22, 2017. The implementation of GST on 30.6.2017 will give positive impact on the growth of economy though it is difficult for some time for the small traders, low income groups and the public. Slowly, the rates of GST will be reduced and the taxation procedures will be relaxed, he hoped.

Dr. C. A. Vasuki madam delivered presidential address. Dr.V.Chinnusamy, Chief Executive Officer of the college offered felicitations. Dr. M. Revathi Bala welcomed the gatherings. Ms. B. Divya Priya proposed Vote of thanks.
