The meeting began with the welcome note by the Chairman. The chairman introduced the new members.

The following suggestions were given by the members of Academic Council:

1. Dr. Krishnan Swaminathan, Member-Academic Council, appreciated and suggested to include anecdotes of famous personalities as a Chapter in the Paper –Moral and Ethics to mould the students to become good human beings. Further he appreciated the Syllabi of Biotechnology and Biochemistry and emphasized that concepts related to Environment and Health can be added as these topics shall open up new vistas for research. Appreciation was given on the inclusion of Industry 4.0 and emphasized to focus on AI, ML, DA and etc.

2. Dr. B. Sampathkumar, Eminent Educationist and Academic Council member, appreciated the successful implementation of 4AR. A Suggestion was given to have an inclusive Department for Fine Arts to the full-fledged execution of the curriculum especially Sanskrit, Hindi, Bharathanatyam and etc., with the approval of UGC. Recommendations were given to instill the interest among the students through the creation of awareness on Tamil Literary Awards. He insisted that the number of beneficiaries in each of the Internship Programme should be mentioned in the Academic Council while it is presented against Action Taken Report.

3. Thiru M.P. Panneer Selvam, Academic Council member, opined that Coimbatore is an industrial city and there are lot of job opportunities for commerce students. Hence he recommended that industry partnered Mock Interviews can be organized to train the students to make them Industry-Ready. He mentioned that focused observation should be given to the components of Internal Assessment. He also strongly emphasized the updation of text books with recent editions as they are mandatory to enrich the curriculum. He suggested to incorporate E-Invoice, E-Way Bill using IRP to equip the students with updated competency. He recommended that in the course (page No UCB 4) and IFC, the components should be more specific rather than generic.
