The Chairman also advised the Secretary and the Principal of the College to ensure 100% admission during next academic year against the 55% admission made during this year, as the pandemic situation is gradually reducing and it is expected that an healthy atmosphere will enable the students to join in more number.

The Members conveyed their happiness over the Appreciation Certificate given to the College by the Ministry of Education (MoE), AICTE and MoE’s Innovation Cell, Govt. of India.

#### **ITEM 9: INDIA RANKINGS 2021 (NIRF)**

All the Members of the Governing Body congratulated the Management, the Principal and the faculty and staff members for securing 36<sup>th</sup> rank in **INDIA RANKINGS 2021** under College category. The Chairman asked how many Colleges are there in India, for which Dr. S. R. Madhan Shankar, Dean Academics replied that approximately there are 16000 Arts and Science Colleges in the country. Among the shortlisted 100 colleges, our



Institution ranks 36<sup>th</sup>. The Chairman requested the Secretary to mention such important highlights in the Notes so as to know the value of Ranking.

Further Dr.S.R.Madhan Shankar, Dean, Academics explained the Members that if a College scores more than 3.5 CGPA, extension will be granted by the UGC for 10 years. All the members suggested the team of faculty to strive hard to get higher CGPA, i.e. more than 3.5 CGPA.

Sri.P.Haridasji, the Senior Member appreciated this special recognition earned by the Institution. Dr.S.R.Madhan Shankar, the Dean Academics informed the Members even the innovative ideas fetch money. Dr. O. N. Paramasivan suggested to motivate all 4000 students to give their innovative ideas and if recognized can turn into benefit. Dr.S.R.Madhan Shankar further informed that during last year 43 students gave their ideas and 3 were judged among them. The Members suggested to tie up with Codissia / small scale industries association and other industries to explore the problems faced by them in the industry and place them before the students to invent solutions and involve them maximum in our activities and discussions.

The Chairman, Er.Thiru.R.Somasundaram and Dr. O. N. Paramasivan, the Member and the other Members acknowledged and appreciated the good efforts taken in this regard.

### **ITEM 31: SKILL HUB – UGC NSDC**

---

The Secretary informed the Members that for the students to join the following two skill development courses run under the UGC Skill Hub Institute, a basic study up to X Standard is adequate and outsiders can also enroll. No fee will be charged to them as the College gets fund from NSDC.

1. Aqua culture technician
2. Plant tissue culture technician

The Members noted and recorded the same.



### **ITEM 32: INCLUSIVE TECHNOLOGY BUSINESS INCUBATOR**

---

The Members noted the proposal submitted to DST to commence a ITBI in the campus and the presentation of the same before the Task Force committee by Dr. S. R. Madhan Shankar, Dean Academics, Dr. G. Dhandapani, Assistant Professor in Botany and Dr. P. Sujatha, IQAC Co-ordinator. The Members appreciated their efforts and wished them to get the scheme for the college.

### **ITEM 33: SPECIAL PURPOSE VEHICLE UNDER SECTION 8 COMPANIES ACT 2013**

The Members were informed that a Special Purpose Vehicle (SPV) entitled “Kongunadu Innovation and Business Association” has been formed with 3 Directors to refine and contribute to the development of Entrepreneurial venture in the district of Coimbatore. The SPV will promote establishment and provide mentor support to new business ventures and start ups. The application has been submitted to Ministry of Corporate Affairs, Government of India and is awaiting for final approval.

### **ITEM 34: DBT SKILL VIGYAN PROGRAMME IN PARTNERSHIP WITH DEPARTMENT OF BIOTECHNOLOGY, GOVERNMENT OF INDIA**

The Members noted the proposal to commence DBT Skill Vigyan Programme submitted to the Nodal Officer of Tamil Nadu State Council of Science and Technology in the month of July 2020 with an aim to commence Students’ Training Programme, Technician Training Programme, Refresher Course/ Faculty Training Programme, Entrepreneurship Training Programme



and Biotechnology Finishing School. Dr.S.R.Madhan Shankar, Dean Academics, presented the proposal to DBT and is awaiting for final approval.

The Chairman, Er.Thiru.R.Somasundaram advised that once the scheme is approved, the details of the same has to be circulated to all the departments of the college to ensure that the benefit of the scheme reaches each and every student in the respective disciplines.

### **ITEM 35: ICT ACADEMY**

The Members of the Governing Body perused the details about the various activities organized by the Faculty of the College in respect of Faculty Development Programme, Skill Development programme, RPA Skill-A-Thon 2021 Programme, Power Seminars and Learnathon 2021. The members also observed the information that our Institution is one among the few institutions who have made 100 students complete the self-learning with a minimum five courses by each student. Dr.S.R.Madhan Shankar, the Dean Academics informed that recognizing our inputs, one lakh worth books have been contributed by ICT Academy which are placed in the Library with proper bar coding.

The Secretary informed the Members that from next year Ethical aspects will be taught. The Chairman, Er. R.Somasundaram suggested to introduce ethical values in the Research programmes. Dr. O. N. Paramasivan suggested to train about the Cyber Security for which the Secretary replied that from this year the department of Computer Science prepared a Book and going to add 2 papers on these lines.

The Members placed on record their appreciation for the good efforts taken by the Faculty and the support extended by the Management in this regard.

### **ITEM 36: CENTRE FOR YOUTH EMPOWERMENT- HONEY WELL**

The Secretary informed the Members that this is a prestigious recognition for the College as our Institution is one among the 15 colleges chosen for this center. The center aims to train and recruit 120 students in the college and the students get a salary package of Rs. 4 to 5 lakhs per annum after getting trained.

The Chairman, Er.Thiru.R.Somasundaram appreciated the report given by the Academic Audit Committee which is a very good review and the College has to follow the points listed out by the Committee and draw up an action plan on the same and implement it. The Principal replied that the review is done in 4AR (Annual Assessment of Action and Achievement Report) meeting. The Members observed about the low graph in Computer Technology. The need for the departmental libraries was discussed. The Secretary suggested to raise funds from their Alumni and to establish individual Libraries in all the Departments. The Members appreciated Dr.S.R.Madhan Shankar for establishing an individual Library for Biotechnology Department. Dr.O.N.Paramasivan suggested to make use of NDLI and EDLI for enhancing book bank/resources.

**ITEM 46: FACULTY DEVELOPMENT PROGRAMME**


---
