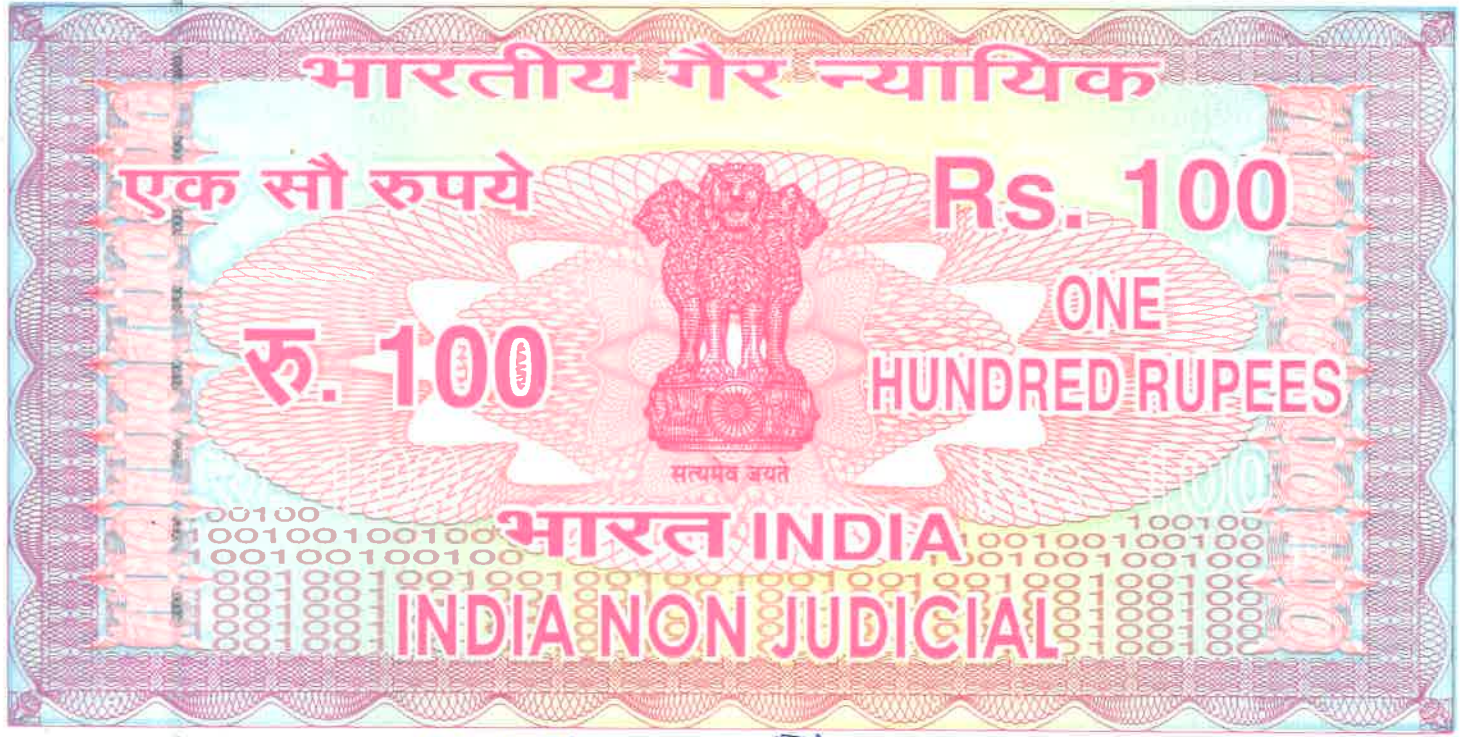

Whereas, 1Corporate Guru is in the business of providing training related Services;

Whereas, 1Corporate Guru at its various departments hereby agree to provide various vocational training to personal referred or nominated by the INSTITUTION.

Whereas, 1Corporate Guru and INSTITUTION hereby agree to collaborate for contributing towards the fulfillment and achievement of knowledge in CRM, Body language, communication skills(Verbal and Nonverbal) to staff members and Students.

Now in consideration of the mutual covenants and undertakings as set forth herein the Parties agree as follows:

1. Objectives:

For the purpose of this MOU, the Parties hereby agree and acknowledge that they shall collaborate to achieve the following objectives (herein after referred as the '**Objective**'):

- a. To facilitate personnel nominated or referred by INSTITUTION to Participate in Workshops and trainings organized at the institution.
- b. To provide staff from the INSTITUTION to get trained.
- c. To participate in workshops, conferences etc and offer guest lectures by the 1Corporate Guru as requested by INSTITUTION.
- d. 1Corporate Guru will, based on availability, participate in mentorship programs and conferences to offer influential talks whenever invited or requested by INSTITUTION.

2. Rights and Obligations:

INSTITUTION

- a. 1Corporate Guru will provide training under its training programs to faculty and students of INSTITUTION;
- b. INSTITUTION will extend their Support by providing the Resources/infrastructure or other initiatives to 1Corporate Guru for training;
- c. INSTITUTION and 1Corporate Guru will jointly design, develop and provide required course materials & practical training like workshops and hands on training to the faculty and students.
- d. 1Corporate Guru will provide INSTITUTION with detailed reports of the faculty members at end of the training.



3. Costs:

INSTITUTION shall bear all costs and fees related to the selection of the faculty.
1Corporate Guru will provide the bestprice quotation for all the upcoming training related programs of INSTITUTION.

1Corporate Guru shall submit the price quotation time to time to INSTITUTION based on the effort by calculating the resource and other overheads.

4. Financials

Package offered by 1Corporate Guru,

- 35 to 70 faculty - Rs 25,000/- per batch (3.00 hrs.)
- 100% payment in advance

5. Validity of the relationship

The framework of the agreement would be initially valid for a period of 2 years. This agreement can be extended by means of an addendum referring to this agreement as the base agreement to set the revised period and terms if any.

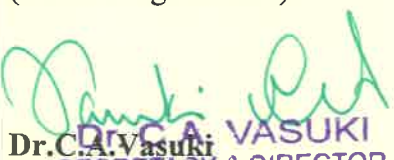
Termination clause

1. If the Pre-Incubator decides to terminate its operations before the mentioned 2-year validity from the date of signing of the MoU, the Institution shall be required to notify the 1Corporate Guru within 2 weeks of its closure.
2. Additionally, the MoU can be terminated from either end, with 30-days prior notice based on mutual consensus on completion of pending engagements and fulfillment of all commercial obligations.

Non-compete / Non-conflict / Engagement protocols

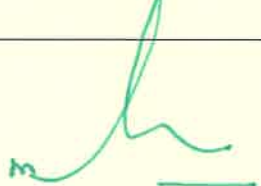
