MINUTES OF THE MEETING OF THE RESULT PASSING BOARD END-OF-SEMESTER EXAMINATIONS, FEBRUARY 2022

All UG, PG, PG Diploma, Diploma and Certificate course candidates Result Passing Board meeting was held on 11/03/2022 at 11.00 am. in the Conference Hall. Dr.M.Lekeshmanaswamy, Principal and the Chairman of the Board presided over the meeting. Dr.R.T.Rajendra Kumar, Professor, Department of Nanoscience & Technology, Bharathiar University Nominee and the other members of the Result Passing Board were present.

A brief account of Feb. 2022 Examinations:

The End-of-Semester Practical/Project Examinations for UG, PG candidates were conducted **through offline mode** between 22/11/2021 and 03/12/2021. The End-of-Semester Practical/Project Examinations for PG Diploma, Diploma & Certificate Course candidates were conducted **through online mode** on 04/02/2022. On-line End-of-Semester Examination for the subjects General Awareness, Food Technology, Competitive Science I, Competitive Skill Enhancement and Common Aptitude Skills were conducted **through MSteam online mode** on 05/02/2022. The End-of-Semester Theory Examinations for UG, PG, PG Diploma, Diploma and Certificate course candidates were conducted **through online mode** between 07/02/2022 and 17/02/2022.

A total of 4098 candidates had registered, out of which 4096 appeared for the Examinations. The Central Valuation for UG, PG, PG Diploma, Diploma and Certificate course **(through Online Mode)** were held between 17/02/2022 and 25/02/2022.

Agenda for discussion:

Item 1. To consider the award of moderation marks:

From the scrutiny of results of the Examinations of Feb. 2022, it was found that for want of one, two or three marks, there were 44 failures in 17 papers in various UG, PG & Diploma courses. According to the Autonomous Examination norms, a moderation of 3 marks could be awarded to a paper for a pass, subject to a total of 8 marks, for a maximum of 3 papers per candidate.

Further, 8 students, who failed in 9 papers by one mark in total, may be awarded one mark to pass a paper as per Autonomous examination norms.

I, Dr.K.Murugesan, COE moved that moderation marks will be awarded to the failed candidates so as to enable them to acquire pass minimum and to declare them to have passed the Examinations.

Result Passing Board unanimously resolved that the above move brought in by the COE regarding the award of moderation marks is approved.

Item 2. To consider the results of the End-of-Semester Autonomous Examinations, Feb. 2022.

I, Dr.K.Murugesan, COE moved that after incorporating the resolution of agenda item 1, the results of all UG, PG, PG Diploma, Diploma and Certificate Course be approved.

Item 1. One student was awarded the following punishment for the malpractice committed by him during the examination of Feb. 2022 as per the decision of the Disciplinary Action Committee.

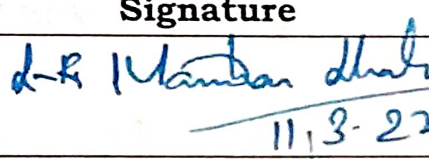
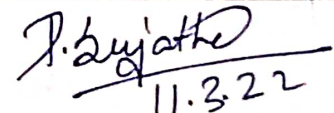
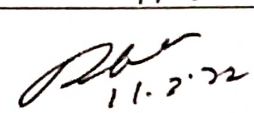
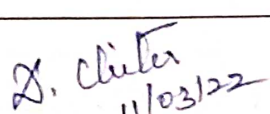
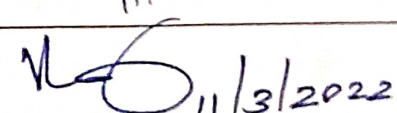

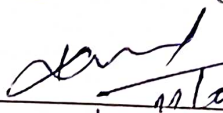
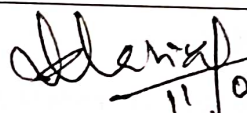
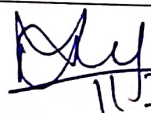
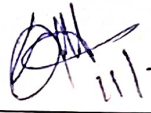
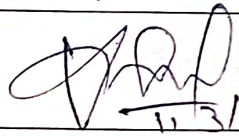
Item 2.

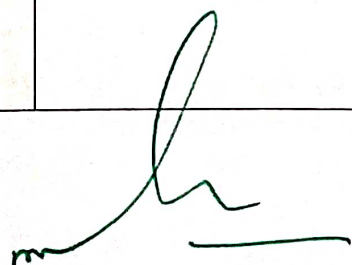

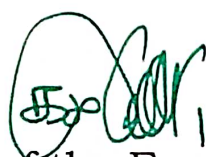
