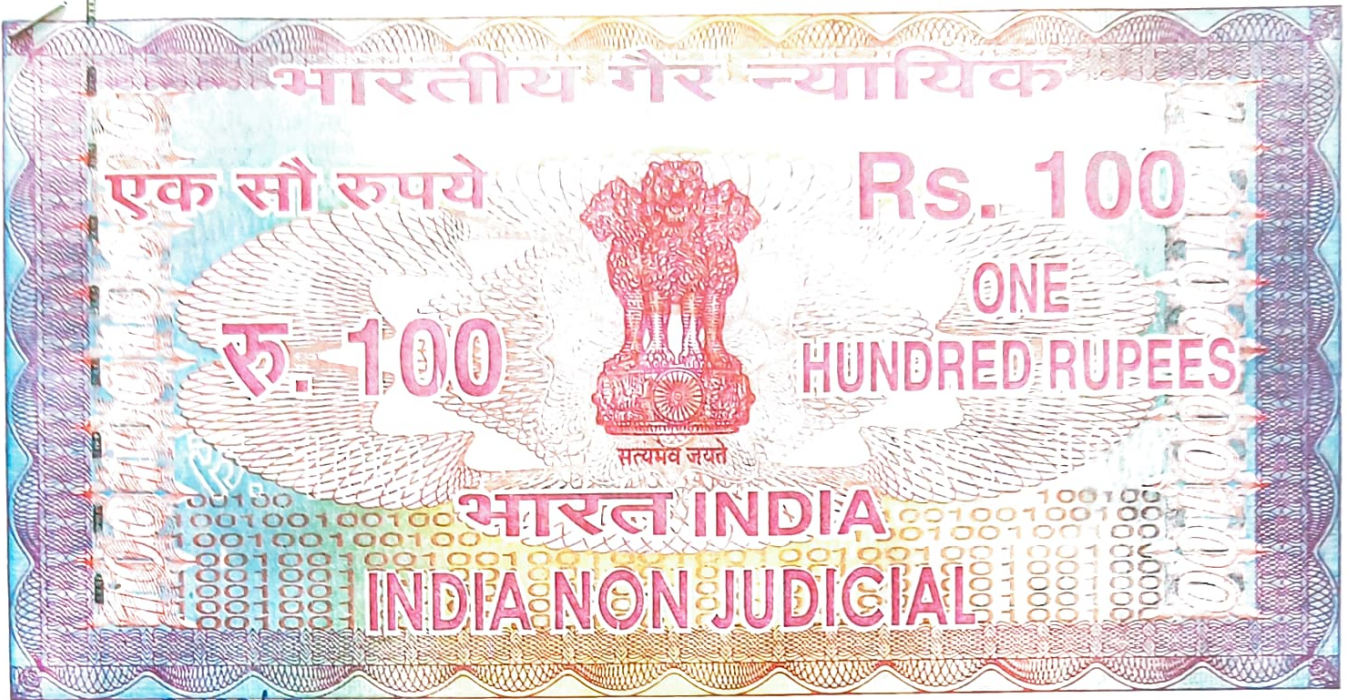

MEMORANDUM OF AGREEMENT

BETWEEN

KONGUNADU ARTS AND SCIENCE COLLEGE, COIMBATORE, INDIA

AND

BANNARI AMMAN INSTITUTE OF TECHNOLOGY, SATHYAMANGALAM, INDIA

The Bannari Amman Institute of Technology with principal offices at its campus in Sathyamangalam, India and Kongunadu Arts and Science College, with principal offices at its campus in Coimbatore, India, wishing to establish co-operative relations between the two institutions, especially in the development of academic and research interchange between the two institutions, agree as follows:

PART I

SCOPE OF CO-OPERATION

The areas of co-operation, subject to mutual consent, include any program offered at either institution considered desirable and feasible by either party, and in the case where both the

institutions feel it contributes to the fostering and development of co-operative working between the two institutions.

The assistance to be provided by each of the contracting parties will research and staff development as deemed beneficial by the two institutions.

PART II GENERAL AREAS OF CO-OPERATION

Assistance shall be carried out, subject to the approval of the Principal, Bannari Amman Institute of Technology and the Principal, Kongunadu Arts and Science College, through such activities or programs as:

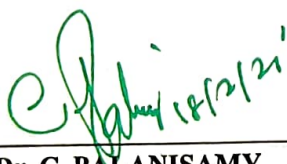
1. Joint research activities;
2. Jointly organize the Seminars, Conferences and Workshops;
3. Participation in seminars and academic meetings;

The terms of such mutual assistance and the budgeting for each program and activity that is implemented under the terms of this agreement shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of the particular program or activity, and such program and activity shall be negotiated on an annual basis.

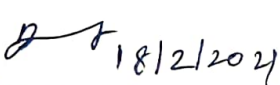
PART III RENEWAL, TERMINATION AND AMENDMENT

This agreement shall remain in force from the date of last signature to a period of three years, with the understanding that it may be terminated by either party giving two months notice to the other party in writing. The agreement may be extended by mutual consent of the two parties. This agreement may be amended by an exchange of letters and/or sub-Memoranda of Understandings between the two institutions. Such amendments, once approved by both institutions, will become part of this document of the agreement.

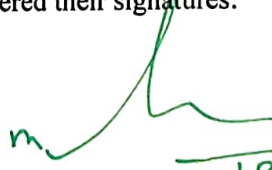

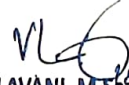
