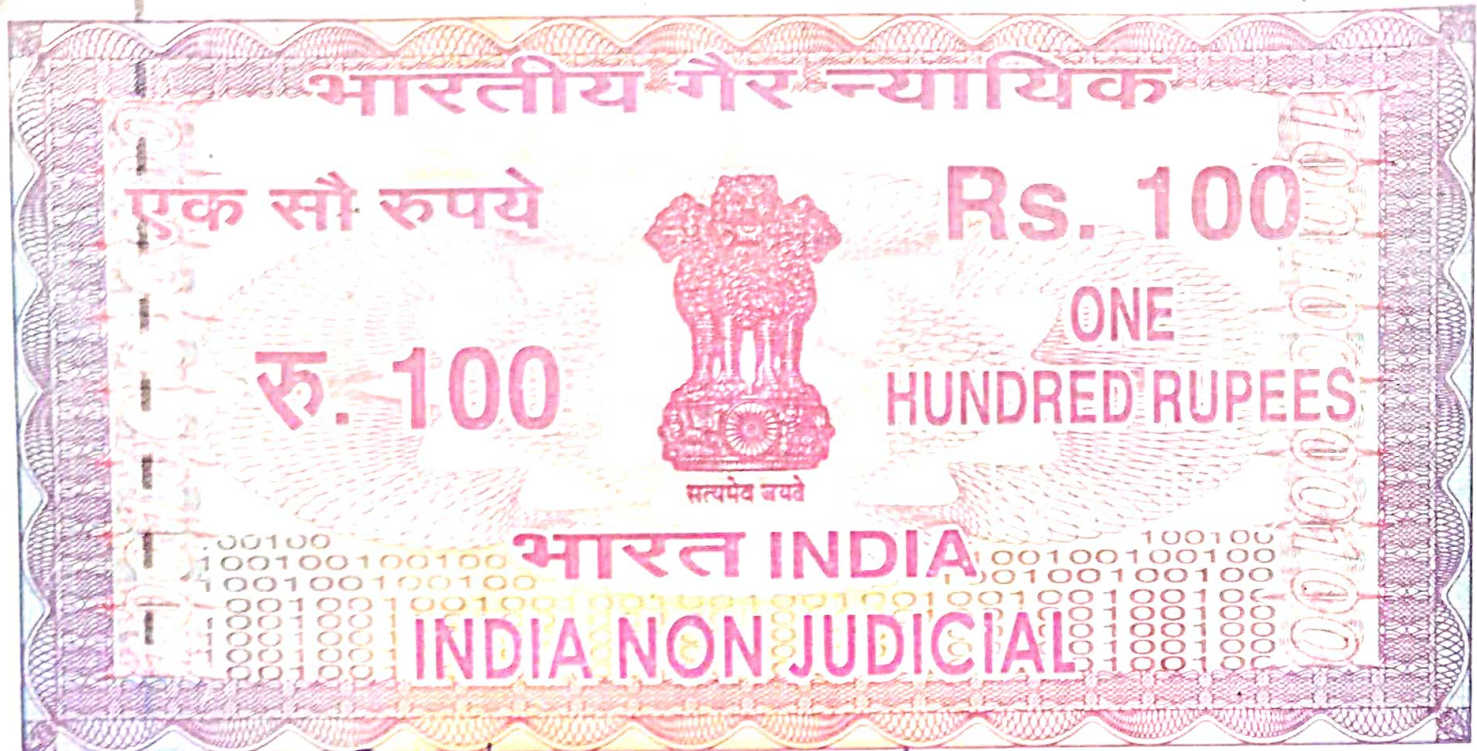

Party B Shall Provide

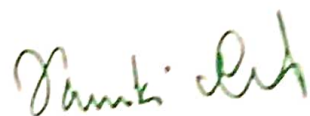
- Shall provide coaching classes to registered students related to SSC & Banking Exams as on the mentioned date, time and schedule as mutually agreed upon by both the parties.

Study Material

Book fee and Study material fee will be charged for registered students. Party A should help Party B collecting the same in a stipulated time from registered students.

JURISDICTION

DURATION

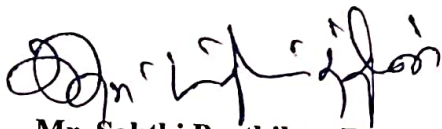
