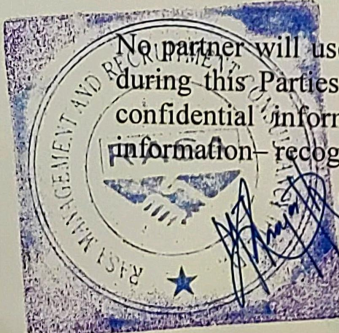
8. Termination
