

MEMORANDUM OF AGREEMENT

The UNIVERSITAS PGRI ARGOPURO JEMBER with principal offices at its campus in JL. JAWA NO.10, TEGAL BOTO LOR, SUMBERSARI, KEC. SUMBERSARI, KABUPATEN JEMBER, JAWA TIMUR 68121, INDONESIA and KONGUNADU ARTS AND SCIENCE COLLEGE, with principal offices at its campus in G. N. MILLS POST, COIMBATORE - 641029, TAMIL NADU, INDIA, wishing to establish cooperative relations between the two institutions, especially in the development of academic and cultural interchange between the two institutions, agree as follows:

PART I

SCOPE OF COOPERATION

The areas of cooperation, subject to mutual consent, include any program offered at either institution considered desirable and feasible by either party, and in the case where both the institutions feel it contributes to the fostering and development of cooperative working between the two institutions.

The assistance to be provided by each of the contracting parties will be teaching, research, exchange of faculty and staff development subject to approved by both the Governments, as deemed beneficial by the two institutions.

PART II

GENERAL AREAS OF COOPERATION

Assistance shall be carried out, subject to the availability of funds and the approval of the Rektor of Universitas PGRI Argopuro Jember and the Secretary, Kongunadu Arts and Science College, through such activities or programs as:

1. Jointly organize the Seminars, Conferences and Workshops either at India or at Indonesia;
2. Joint research activities;
3. Participation in seminars and academic meetings;
4. Exchange of academic materials and other permissible information;
5. Special short-term or long-term academic programs.

The terms of such mutual assistance and the budgeting for each program and activity that is implemented under the terms of this agreement shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of the particular program or activity, and such program and activity shall be negotiated on an annual basis. Each institution will designate a Liaison Officer to develop and coordinate specific activities or programs.

PART III

RENEWAL, TERMINATION AND AMENDMENT

This agreement shall remain in force from the date of last signature to a period of three years, with the understanding that it may be terminated by either party giving two months notice to the other party in writing. The agreement may be extended by mutual consent of the two parties.

This agreement may be amended by an exchange of letters and/or sub-Memoranda of Understandings between the two institutions. Such amendments, once approved by both institutions, will become part of this document of the agreement.
