
Sir,

With reference to the proposals of the following five Colleges received through Bharathiar University and concurrence of the State Govt. of Tamil Nadu given by its representative during the Screening Committee meeting held on 25th-26th February, 2004 at UGC for shortlisting colleges of the Tamil Nadu State, I am pleased to inform that Commission at its meeting held on 13th August, 2004, considered the reports of the Expert Committee which visited five Colleges of Bharathiar University from 12th to 16th July, 2004. Based on the recommendations of the Expert Committee, the Commission AGREED to grant of autonomous status to the following Colleges for the period mentioned against each as under:

5.	Dr. G.R. Damodaran College of Science, Coimbatore	From 2004-2005 to 2009-2010



Sir/Madam,

This is with reference to the proposal submitted by Kongunadu Arts and Science College, Coimbatore-641 029 (Tamilnadu) affiliated to Bharathiar University, Coimbatore for extension of autonomous status under the UGC Scheme for Autonomous Colleges.

On the basis of the report of the UGC Expert Committee and on the basis of the recommendations of the Standing Committee, the Commission at its meeting held on 22.12.2017 has decided to grant extension of autonomous status to Kongunadu Arts and Science College, Coimbatore-641 029 (Tamilnadu) affiliated to Bharathiar University, Coimbatore for a period w.e.f. 2017-2018 to 2021-2022.

Bharathiar University Coimbatore-641 046 (TN) may issue necessary notification/order regarding the grant of extension of autonomous status to the college as per the UGC Guidelines for Autonomous Colleges. The college, if eligible, shall apply for autonomy grant as per the norms laid down in the Guidelines.

The autonomous college shall be guided by the provisions of the UGC Guidelines for Autonomous Colleges. The Guidelines are available on the UGC website, www.ugc.ac.in. However, the college may take special note of the following:

- (a) The college will constitute the Internal Quality Assurance Cell (IQAC) under intimation to UGC. The Cell will have an external Peer Team comprising of academicians of repute and will send report to UGC regarding the performance of the college. The report will also be put on public domain on the website of the College. The external peer review shall be conducted atleast once in a year.

- (b) If the college is currently accredited by NBA only, it must undergo NAAC accreditation within two years of conferment of the autonomous status.
- (c) The college will apply to University Grants Commission for extension of autonomous status six months prior to expiry of the autonomy cycle. If the college does not apply within the stipulated time, University Grants Commission will be at liberty to withdraw the autonomous status of such college.


